
2A – Flood warnings: Triggers and actions

Trigger (any one or more)	Actions by Flood Wardens
Flood Alert/Met Office weather warning issued	APPOINT A CO-ORDINATOR (if the usual person is not available)
Relevant information from resident(s) living by river	CHECK WHICH WARDENS WILL BE AVAILABLE DURING PERIOD OF WARNING
Recent weather indicators	
	Co-ordinator:
River near top of arches at Jacks Bridge	 makes initial contact with locations at risk
	 Environment Agency, Parish Council, Village Hall
River near top of arches at Townend Bridge	
	Co-ordinator manages Flood Warden activities appropriate to level of risk
	Ensure all drains are clear in areas at risk (see Table 2B)
	Ensure equipment available
	Make contact with those on Vulnerable List
	 Advise property owners to put up property flood defences and follow their flood plans – check if any resident needs help to do so
	Prepare for traffic diversion
	Take photos of river, particularly at bridges
	Measure river height



Area 4	Long Street from village shop to Elderwell Lane – House flooding possible Road flooding and traffic disruption possible	Overflow from River Sheppey Water running along road and accumulating at low point Groundwater	River overflow (river flows approx east to west) Road flooding from centre running to east From below
